AUCTION NOTICE

No.AASC(B)264/2011/33, Dated Guwahati the 9th July 2013

The following air conditioners and voltage stabilizers belonging to Assam Administrative Staff College are proposed to be disposed of on 'as is where is' basis. Interested bidders will have to submit a bank draft of **Rs.5000/- (Rupees Five thousand only)** as earnest money payable in favour of Director of Training, Assam Administrative Staff College, Khanapara, Guwahati – 22 along with their sealed tenders, which should be affixed with non-refundable court fee stamp of **Rs.8.25/- (Rupees Eight and twenty five paise only)**. The unsuccessful bidders will be refunded their bank drafts subsequently. The tenders will be received up to **2 PM of July 31, 2013** and will be opened on the same day i.e. **July 31, 2013 at 3 PM**. In case any of these days happen to be a holiday, the specified activity will be undertaken on the next working day. No outsiders except the bidders will be allowed to enter the office premises without prior authority of the undersigned on the date of opening of the tenders.

The bid will be started from the minimum rates as shown below:

Detailed information regarding the air conditioners and voltage stabilizers may be collected from the undersigned during the office hours on all working days. They may also be inspected during office hours on any working day.

The tenderers will have to quote for the entire quantity of the specified materials they intend to bid for.

After opening of the tenders, bidders will have to deposit the entire amount of bid less the amount already deposited as bank draft. On the same day i.e. **July 31, 2013** the air conditioners and voltage stabilizers are to be taken out from the premises by the successful bidder at his own cost. If the highest bidder who is present at the time of opening the tenders is not able to deposit the bid money, his earnest money will be forfeited.

This cancels the auction notice issued vide No.AASC(B)264/2011/21, dated Guwahati the 6th of May 2013.

In case of any dispute, the decision of the Director of Training, Assam Administrative Staff College will be final.

The Director has the right to reject any or all tender papers without assigning any reason thereof.
